2. Academic Program(Master of Laws)

Development of regional & international cooperation and World Peace

The Basic goal of the TLBU system is to strengthen the friendship and cooperation of regional and international society through educational exchange program. East Asian society is comparatively weak in regional and international exchange and cooperation.

For the regional cooperation of East Asia, TLBU Graduate School of Law in Seoul provides a common education program of East Asian elite students who graduated from the best law schools in each of their respective countries. TLBU Graduate School of Law provides scholarship to all students.

For international cooperation, TLBU global system is composed of TLBU Graduate School of Law, TLBU Global School in Seoul (Bilingual Primary and Secondary School), TLBU Foundation and International high school in USA. TLBU Global System provides various international educational exchange programs.

2. Academic Program(Master of Laws)

▪ In-depth Study of International Law

With the rapid pace of change in the global society, we inevitably have shifted our focus to international legal knowledge, instead of restricting our interests to domestic law. TLBU Graduate School of Law in Seoul will provide intensive lectures on International Law.

▪ 1+1 Program

Well-qualified students are can enroll for the TLBU's unique 1+1 program with the US university including Temple University Law School. Students eligible for 1+1 Dual Degree Program have special grant offered by Temple Law School and TLBU Foundation in US may offer loans to the students for study in the US.

After one year of intensive training in English by the teaching staff at TLBU, students are admitted into the LLM Program offered by the US Law schools. The students are required to be residence for one year and enrolled for the 2nd year at TLBU while studying for LLM Degree in the US. The students are required to submit their dissertations in accordance with the TLBU regulations before the 2nd year to be granted Master's Degree at TLBU. Credits earned abroad may be recognized according to the relevant rules of TLBU.

▪ 2 Year Master of Laws Program at TLBU in Korea

Students opting for study for 2 years for Mater of Laws program will receive intensive training from well qualified teaching staff at TLBU in Korea

▪ Education of Social Responsibility for Potential Leaders

It is our aim to educate the finest law students, however we do not limit our objectives to just providing education on legal studies. The opportunities for students to participate in various volunteer activities will also be available. By doing so, our students will learn to recognize the importance of the social responsibility of a potential leader. It is our objective to provide our students with proper knowledge on law, as well as guiding our students to live as a role model for others to follow.

3. Qualifications

- **English Proficiency**

The applicant should have at least 550 Paper-based TOEFL (PBT), 213 Computer-based TOEFL (CBT), 80 Internet-based TOEFL (IBT), band 5.5 IELTS scores.

- **Prerequisite Legal Education**

Applicants for Master program must have been received, or expected to receive by the end of February, 2023, a bachelor`s degree (or equivalent) in law from an approved institution.

Applicants for the doctorate program must have been received, or expect to receive by the end of February, 2023, a masters degree (or the equivalent) in law from an approved institution

A final transcript confirming your graduation should be submitted as soon as it is available. We reserve the right to review for reconsideration or revoke the offer of admission if you fail to graduate with your class.

- **Letter of Recommendation**

Arrange for the timely submission of one letter of recommendation from a professor under whom you have studied (preferably in high-level courses in your major field of study). If you have been out of school for some time you may submit letters from employers or associates.

- **Interviews with Applicants**

Students will have phone or online interviews instead. TLBU Academic Affairs Office will notify all the applicants of exact date for the interviews in due course.

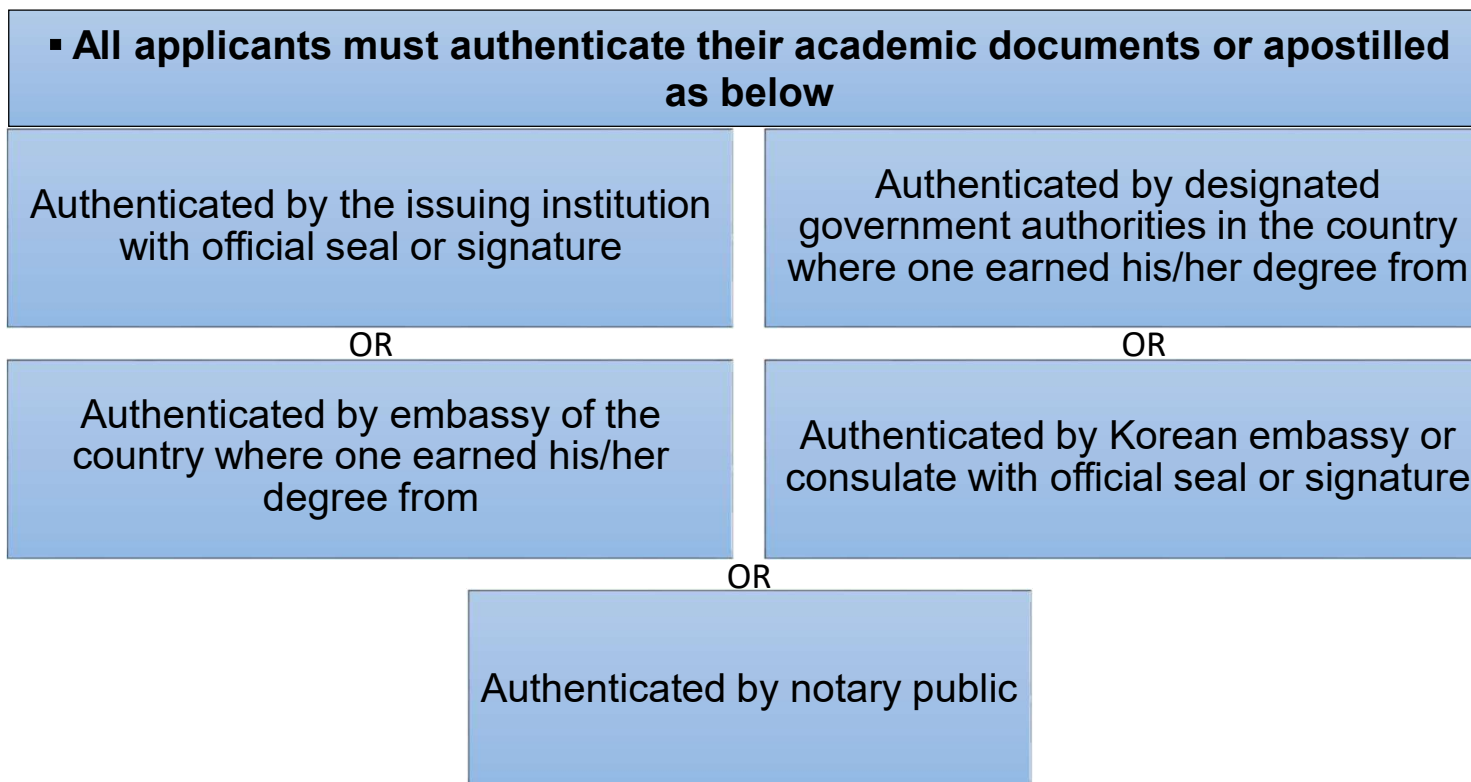

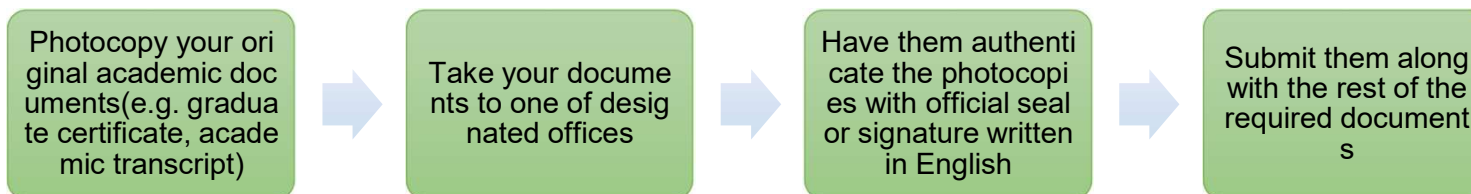

6. Important Notices

Applicants are responsible for properly completing their application and sending their supporting documentation to TLBU on time. Please keep in mind that it may take **more than one month** to prepare all required documents. Early preparation is highly encouraged.

Applicants are also responsible for their visa

- All required application documents must be submitted in one package via postal mail (or in person) at the Academic Affairs office of TLBU by the deadline.
- We suggest that applicants submit their application's documents as early as possible.
- TLBU will not be responsible for any consequences caused by incorrect information in the application.
- The important notices are delivered via email entered in each application.
- If the information in the application documents is unclear or if any parts of the application documents are missing, the application will not be submitted for evaluation. If the above issues are found after the admission has been offered, the offered admission will be revoked.
- The submitted application documents will NOT be returned.
- All application documents must be typed (not hand-written) in English.
- Non-English based documents(original/certified) must be accompanied with notarized English translations.
- If any required documents are found to be false or counterfeit, admission to TLBU will be revoked.
